- Demonstrate a sound basic knowledge of domestic abuse
- Hear disclosures from victims and know what questions to ask
- Work with and challenge perpetrators of domestic abuse
- Be clear on the limits to confidentiality
- Understand the pattern of separating and reconciling with abusers
- Have a sound understanding of the impact of domestic abuse on children
- Have increased confidence in working with domestic abuse in minority cultures
- Recognise and respond to risky situations including imminent danger
- Feel confident in completing work with families on safety planning and 'managing' risk themselves.

Risk Assessment

What constitutes risk? How do we demonstrate that a client poses a risk? Risk of what? To whom? In what circumstances? What are the best predictors of future behaviour? In a review of serious case investigations DV-ACT has found that in 94% of cases recommendations were made to improve the quality of risk assessment in cases of domestic violence and abuse. One of the most crucial learning points was the tendency among professionals to place too much emphasis on clinical judgement and ignore vital static risk indicators. The training in domestic violence risk assessment has been designed with the lessons from serious case reviews in mind. By the end of this course participants should be

able to:

- Identify static indicators of risk and use them to reach an accurate assessment of the baseline level of risk
- Identify dynamic risk indicators and use them to create risk management plans and make adjustments to the baseline level of risk
- Understand the cycle of violence and abuse as presented by perpetrators themselves
- Use tools and techniques to help victims and perpetrators to manage risky behaviour
- Conduct focused and practical safety planning with the child's well-being at the centre of the concerns.



Vulnerability & Attachment

This training day is designed to help social workers feel more confident in their work with clients who have an attachment to their abuser and where there is a likelihood of reconciliation following separation. After attending, practitioners should be able to:

- Identify key indicators of vulnerability
- Assess the likelihood of ongoing attachment and reconciliation and be able to work with victims in this area
- Have a sound knowledge of the most common cycle of violence
- Approach victims and children with confidence and know what questions to ask
- Make a judgement about treatment suitability.
